**The Focused Pastor Couples Conference Giveaway 2025**  
**OFFICIAL RULES**

Participation in The Focused Pastor Couples Conference Giveaway 2025 Sweepstakes (the "Sweepstakes") is contingent on your full and unconditional agreement to and acceptance of these Official Rules. The Contest is sponsored by Focus on the Family, 8605 Explorer Drive, Colorado Springs, CO 80920 ("Sponsor").

**1. NO PURCHASE NECESSARY TO ENTER.**

**2. Sweepstakes.** The Sweepstakes will be held between August 15, 2025, and September 1, 2025, inclusive (the "Sweepstakes Period"). Entries must be received during the Sweepstakes Period. Time of entry is Mountain Time.

**3. How to Enter.** To enter the Sweepstakes, complete the required fields in the Sweepstakes entry form found at <https://forms.office.com/r/kj1yrqRsWP>. Upon completing and submitting the form, you will have entered the Sweepstakes. One entry per person.

**4. Agreement to Official Terms and Conditions.** By participating in this Sweepstakes, entrants agree to abide by these Official Rules. Any entrant or winner who violates these Official Rules is subject to disqualification at any time at Sponsor's sole discretion.

**5. Eligibility.** Participation is open only to church pastors or those serving in a recognized pastoral ministry position, who are age 18 or older and who are legal residents of the fifty United States and its territories and possessions, and the District of Columbia. Entrants are subject to all federal, state and local laws, rules and regulations. Void outside of the 50 United States, its territories and possessions, and the District of Columbia, and where prohibited, taxed or restricted by law. Employees, officers and directors of Sponsor and its affiliates, partners, advertising and promotion agencies, any agencies involved with administering the Sweepstakes, manufacturers or distributors of Sweepstakes materials and prizes, and their immediate families (parents, children, siblings, spouse) or members of the same household (whether related or not) of such employees/officers/directors are not eligible to enter.

**6. Prize; Random Drawing/Odds.** Five (5) winners will be selected by Sponsor in a random drawing after the conclusion of the Sweepstakes Period, from among all valid entries received during the Sweepstakes Period. Each winner will receive two complimentary registrations (for pastor and spouse) to attend The Focused Pastor Couples Conference, October 20-22, 2025, at the Focus on the Family campus in Colorado Springs, CO. Travel, meals, lodging, and all other expenses incurred by winner are the responsibility of winner. The odds of winning depend on the number of eligible entries timely received. Sponsor is responsible for determining the winners of the Prizes in its sole discretion, subject to these Official Rules. All decisions made by Sponsor concerning the award of Prizes shall be final and binding. Entrants are eligible to win

only one Prize. Prizes may not be assigned, transferred, changed, or redeemed for cash, except at Sponsor's sole discretion.

**7. Consumer Disclosure of Prize.** The prize is valued at \$149.50 per person, totaling \$299 per winner.

**8. Notification.** Winner notifications will be made within fifteen (15) days of selection. The winner must respond affirmatively to Sponsor's notification as a selected winner within five (5) days of Sponsor's attempt to notify winner, or the prize will be forfeited, and Sponsor may, but has no obligation to, select another potential winner. If any winner cannot be contacted or does not respond as specified above, if any prize notification is returned as undeliverable, if the winner rejects a prize, if the winner indicates their inability to travel to Colorado Springs for the Couples Conference on October 20-22, 2025, if the winner does not complete and return a W-9 form for tax reporting purposes (if requested by Sponsor), or in the event of noncompliance with these Sweepstakes rules and requirements, such prize will be forfeited. Upon prize forfeiture, no compensation will be given. An alternate winner may be selected from all remaining eligible entries at Sponsor's discretion.

**9. Conditions.** All federal, state and local taxes are the sole responsibility of each winner. Participation in Sweepstakes and acceptance of Prize constitutes each winner's permission for Sponsor to use the photograph as submitted in the entry, name, address (city and state), likeness, photograph, picture, portrait, voice, biographical information and/or any statements made by a winner regarding the Sweepstakes or Sponsor for advertising and promotional purposes without notice or additional compensation, except where prohibited by law. **10. Additional Terms.** In case of dispute as to the identity of any entrant, entry will be declared made by the authorized account holder of the email address submitted at time of entry. "Authorized Account Holder" is defined as the natural person who is assigned an email address by an Internet access provider, online service provider, or other organization (e.g., business, educational, institution, etc.) responsible for assigning email addresses or the domain associated with the submitted email address. Any potential winner may be requested to provide Sponsor with proof that such winner is the Authorized Account Holder of the email address associated with the winning entry. Any

other attempted form of entry is prohibited; no automatic, programmed; robotic or similar means of entry are permitted. The Sweepstakes Entities are not responsible for technical, hardware, software, telephone or other communications malfunctions, errors or failures of any kind, lost or unavailable network connections, web site, Internet, or ISP availability, unauthorized human intervention, traffic congestion, incomplete or inaccurate capture of entry information (regardless of cause) or failed, incomplete, garbled, jumbled or delayed computer transmissions which may limit one's ability to enter the Sweepstakes, including any injury or damage to participant's or any other person's computer relating to or resulting from participating in this Sweepstakes or downloading any materials in this Sweepstakes. Sponsor reserves the right, in its sole discretion, to cancel, terminate, modify, extend or suspend this Sweepstakes should (in its sole discretion) virus, bugs, non-authorized human intervention, fraud or other causes beyond its control corrupt or affect the administration, security, fairness or proper conduct of the Sweepstakes. In such case, Sponsor may select the winners from all eligible entries received prior to and/or after (if appropriate) the action taken by Sponsor. Sponsor reserves the right, at its sole discretion, to disqualify any individual it finds, in its sole discretion, to be tampering with the entry process or the operation of the Sweepstakes or web site. Sponsor may prohibit an entrant from participating in the Sweepstakes or winning a Prize if, in its sole discretion, it determines that said entrant is attempting to undermine the legitimate operation of the Sweepstakes by cheating, hacking, deception, or other unfair playing practices (including the use of automated quick entry programs) or intending to annoy, abuse, threaten or harass any other entrants or Sponsor representatives.

Any such controversy or claim shall be arbitrated on an individual basis, and shall not be consolidated in any arbitration with any claim or controversy of any other party. The arbitration shall be conducted in the State of Colorado, City of Colorado Springs.

THESE OFFICIAL RULES AND THE INTERPRETATION OF ITS TERMS SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF COLORADO WITHOUT REGARD TO ITS CONFLICTS OF LAWS RULES. For any matters which are not subject to arbitration as set forth in these Official Rules and/or in connection with the entering of any judgment on an arbitration award in connection with these Official Rules and/or the Sweepstakes, the parties irrevocably submit and consent to the exclusive jurisdiction and venue of the state and federal courts located in or closest to the County of El Paso, in the State of Colorado. The parties agree not to raise the defense of forum non conveniens.
